Meeting called to order by Mary SM 7:07 at pm. Centering led by Rev Denis, reading from <u>Lifting our</u> Voices – Living Tradition. Check-in of members present.

Motion made by Shirley to dispense with reading of the March minutes. Diana seconded and motion passed. Motion made by Shirley to approve the minutes of April 11, 2020. Motion seconded by Mary M. Motion passed (1 abstention).

Moved up in agenda:

Committee for Developmental Minister search: Nancy went report. We had 1 candidate, who subsequently withdrew because of concern about time commitments for serve 2 congregations at the same time. Have had a number of conversations with UUA contacts of Renee and Christine about our situation. While we had been told there were more ministers looking that positions open, it's in fact more like 1:1 because of covid fatigue. Renee has offered to do an open Zoom call with the congregation. Some concerns that we are not offering more money, but not sure this would make a difference, and NEW Ohio isn't the most appealing location. So we may need to seriously look at compensation issues. Part-time vs Full time is also probably a major issue. Did UUA "lead us on?" -promising that there were more ministers than churches searching. For settled ministers 21 searching and 68 searching. But that didn't happen this year- lots of ministers were in a very focused search for a specific congregation, and if they didn't get that they withdrew. Is ¾ time really a deal-break issue? Possibly. Half time may be easier to fill the other half time. Nancy will put an abridged version on the report in the next Beacon.

Nominating committee: proposed chair is Mary Mason, vice chair is Kristine Burkwood, Asst Treasurer is Sue Borstein, RE chair Minna Zelch (continuing) with Mae Kowalki assisting, Trustee is Bree Byrd. Treasurer Shirley Hairston, Financial Sectry Mark Guizlo – both continuing, and will need 2/3 vote of members present. New nominating committee: Gayle Swain, Dee Beacham, Maureen Heulsenbeck, Barb Opie from whom we need to elect 2. Mary M moved to approve the slate as presented. Shirley and Maggie seconded. New Business:

- 1. Survey Results: 38 responses. 36 said moving meeting later and gathering outdoors would be acceptable (2 no votes). Reviewed rest of results.
- 2. Annual Meeting: What are the risks of doing the annual meeting outside? Last year was by mail, which may be a better way to reach out to every member. Bylaws say annual meeting must be April/May June with 30 days notice (postmark or email stamp). Doesn't have to be either/or make it a combined format, but with a survey monkey survey so people can only vote once. Last year- with online meeting and online voting worked well. Make potential in-person gathering just a gathering, not the meeting. Maggie suggested having people bring food (instead of cooking pancakes for everyone), Patrick suggested lunch is a better meal. Recommendation: In person gathering June 20 is fathers day (picnic), June 27 for annual meeting. Shirley moved the annual meeting be June 27th at noon and it be virtual, and Mary M seconded. Discussion: Shirley would have an open zoom meeting on the 16th for financial review discussion at 11:00 -1:00. Search Committee will also offer to host a zoom meeting about the search process (dates to be determined). Passed unanimously. Diana asked about whether Rev D would be available for a July farewell party-and he just doesn't know at this point. Just not on July 20th.

- 4. Nominating Committee see above
- 5. Ad Hoc Committee for Organizational Restructuring See report Dick Hurwitz sent explaining current status. Basic conclusion is that we can't really move forward until we can start gathering in person. One reason for holding off is that a lot of the people who might take a leadership role just haven't been very active virtually. Consider both 1) identifying where there has been progress and 2) set a date far enough out in the future when we are gathering in person to restart the process (and staying with current structure until then). Halcyon wants to consider keeping the Journey Council moving forward (even though it isn't

- completely formed because 2 of the 6 spokes aren't functional yet). It's unclear how many people are going to want to come back to in-person services because they like the ability to stay at home on Sunday mornings. Discussion tabled for 3 months.
- 6. Ad Hoc Committee for Potential Reopening East Shore- meeting next week. Approved their making recommendations via email.
- 7. Committee for Developmental Minister search- see above.

Old Business:

1) ESUUC Stewardship campaign. Pledges total \$170,173, and still a few people who will likely pledge. Mary is continuing to reach out to these. Almost everyone who pledged/paid last year pledged again this year. Mary and her committee were warmly thanked. Budget: need to recognize that last 3 years budgets relied on "extra" funds (PPE or bequests). There is money left over from 2020-21 because the building wasn't open, which goes back into a special bequest fund to replenish it for future years. Mary SM moves to approve 2021-22 budget to be presented, as edited, at the annual meeting. Mark G seconded. Passed unanimously.

Update from the Ministry Search Team as of 5.05.2021

A candidate applied via the UUA portal on Saturday, May 1. The Search Team reviewed the MR (Ministerial Record) and voted to proceed with an interview. We emailed a 'packet' of information to the candidate Sunday evening. The packet included:

- Links to our website, Youtube, and Facebook sites
- New Organizational plan and pilot timeline
- Our Bylaws
- Draft Minister's Contract
- Copies of our Income/Expense statements, Treasurer's Report, and Board minutes

We learned on Tuesday May 4 that the candidate withdrew their name from consideration. We are in contact with the candidate to see if they can offer some feedback on why they withdrew.

After several conversations with Renée Ruchotzke and Christine Purcell of UUA over the past four months, we continue to be advised to leave our position open through May 18. Christine's most recent response is below:

"We sent a note out with the interim newsletter yesterday to remind ministers in search that this opportunity is still open. I hope that will help.

This has turned out to be a really hard year for a ministry search. We just learned this weekend that we have a 1:1 ratio of searching congregations to ministers in the interim search, for example. Far fewer ministers are looking this year than in recent memory, likely due to the pandemic and to exhaustion. Those who do search tend to seek full time ministry opportunities. In a typical year, I might suggest trying to boost compensation a bit, though your offer is in the recommended range, but this year some full-time positions with mid-point compensation are receiving very little attention in the interim search.

I am not available on Saturday, but I will eagerly connect with ESUUC's leadership, Renee, and the transitions office staff as we consider possibilities for helping to meet ESUUC's ministry needs if there are not further applicants to consider in the next two weeks."

Renée is trying to join our standing Saturday Search Team meeting this week, though we don't yet have confirmation that she can make it.






