Meeting called to order by 2:07. Check in with Rev George reading from Amanda's Gorman's poem a New Year's Lyric. Check in.

Motion made by Shirley to dispense with reading of the November 21, 2021 Minutes; Clark seconded and motion passed. Shirley moved and Mary SM seconded to approve the minutes from December 19, 2021

COM report moved to top of agenda: Met Wednesday last week. Rev Joe said the ministers are happy that Rev Meg is joining the team. All MOUs are signed. Rev Meg is supporting WA, Rev Joe is doing more pastoral care. Great feedback re: Blue Christmas service. Some challenges with morphing back into virtual services- though Rev Meg has some experience with this. Some feedback re: opening portion of service being on Facebook- since some congregants choose not to be on facebook.  $\rightarrow$  Nancy to send COM minutes to Halcyon. There is a way for people to participate in Facebook activities without an account (one person does meditation this way without an account). The ministers want to make sure we feel "held" during these times.  $\rightarrow$  Shirley offered to host social BnB gatherings (Shirley

to contact Rev Joe first to work out details). Now that agreements are set for 6 months we can dig in more to what needs to be done.

### **Reports:**

- A. Chair no report sent. Chair is appreciative for Kristine helping with the work to find a replacement for Linda Work. Reviewed membership list with names of donors, culled some names but → still needs to review this with past chairs and Patrick/membership chair and then will reach out to them to see if they want to continue being a member. New minister search team has posted new congregational record.
- B. Minister no written report. Ministers met last week. They are all appreciative of the efforts by people- particularly Halcyon- when we moved back to virtual services just before Christmas. She did an AMAZING job. Discussed "being held" and they will incorporate that into services.
- C. Faith Development Report sent, attached. Halcyon is editing most of the Sunday services. Ad Hoc on reopening meeting won't be until Jan 27<sup>th</sup> wants to confirm that we will stay closed in Feb. (answer is yes). Halcyon can do the newsletter as a transition between Linda and new person. Will ask Rochelle if she can help. Kristine suggested someone else take this on and → Mary said she would ask the congregation to step up and volunteer to take this on.
- D. Building and Grounds: no written report. The Ad Hoc committee on Building our Future did meet and is gathering information to move forward.
- E. Membership report sent. Membership 145. Patrick is working on congregational certification report to UUA but that is based on numbers from last July (not current list Mary M is working on. Probably won't have great Chili cookoff in February- maybe April, or maybe work on pancake breakfast in June.
- **F.** Treasurer Report In good shape. Have 75% of pledge income in for the year which is great. BJ Roberts does our W2's and tax returns and this is an amazing blessing for us. Thanks to her. Loose offerings down. (correction: 4<sup>th</sup> bullet should say January). **Maggie moved and Clark seconded to approve treasurers report as corrected. Passed unanimously.**
- G. Financial Secretary: Report sent- attached. DRE amount is high because of contract changes. Electricity costs seem to be running high might need to look at that. Mortgage is running low b/c mortgage was renegotiated. Grounds maintenance includes removing the trees, which wasn't part of the budget.
- H. Committee on Ministry: See above.
- I. Ad-hoc committee on reopening: Committee will meet again on January 27th. Continuing to follow CDC Guidelines. Positivity rates for all 3 counties are still very high so we will likely stay closed through Feb.
